Glossary of Terms: Average Credit Quality gives a snapshot of the fund's overall credit quality. It is an average of each bond's credit rating, adjusted for its relative weighting in the portfolio. **Credit Quality** is a measure of a bond issuer's ability to repay interest and principal in a timely manner. High yield credit rating is based on S&P

ratings and Moody's equivalent if unrated by S&P. A rating provides no indicator of future performance and is not constant over time. **Average Maturity** is the length of time until the average security in a fund will mature or be redeemed by its issuer. It indicates a fund's sensitivity to interest rate changes: longer average weighted maturity implies greater volatility in response to interest rate changes. **Average Weighted Coupon** is calculated by weighting each bond's coupon by its relative size in the portfolio. **Conversion Premium** is the amount by which the price of a convertible security exceeds the current market value of the common stock into which it may be converted. A conversion premium is expressed as a dollar amount and represents the difference between the price of the convertible and the greater of the conversion or straight bond value. **Delta** is a measurement of an option's price sensitivity to a given change in the price of the underlying asset. **Effective Duration** is a measure of a portfolio's price sensitivity to interest rate changes, including expected changes in cash flows caused by embedded option. **Yield to Maturity** is the total rate of return earned when a bond makes all interest payments and repays the original principal. It is the single discount rate that equates a security price (inclusive of accrued interest) with its projected cashflows.
